DEED OF DECLARATION OF TRUST

THIS DEED OF DECLARATION OF TRUST made on this 05th day of May 2018 by Mr. E. SENDHIL KUMAR, S/o. Mr. B.R. Ethiraj, residing at No. 29, Dr. Guruswamy Road, "Harmony", Flat No. 2A, 2nd Floor, Chetpet, Chennai 600 031. (HEREINAFTER CALLED THE AUTHOR) is as under:

WHEREAS the AUTHOR is desirous of forming a Charitable Trust

AND WHEREAS he has appropriated a sum of Rs.1,001/- for utilising towards the object of the trust and the said sum as initial donation.

WHEREAS the sum of Rs.1,001/- as a aforesaid has been vested by the donor herein as and for the object of the Trust.

AND WHEREAS it is desirable to reduce the terms and conditions of this Trust here in after appearing.

NOW THIS DEED OF DECLARATION OF TRUST WITNESSETH:

1. The Name of the Trust shall be **NOVA KALVI ARAKATALAI**.
2. The Office of the Trust shall be at No. 29, Dr. Guruswamy Road, Harmony Flat No. 3A, 3rd Floor, Chetpet, Chennai - 600031 or such other place or places as the Board of Trustees may fix from time to time.
3. The amount endowed by the Author, Sri E. Sendhil Kumar is Rs.1,001/- (Rupees One Thousand and One only) is hereby declared as held in Trust for the objects set out hereunder and is hereby vested in the Board of Trustees and shall constitute the initial capital fund (Corpus) of Trust which may be augmented by further donations, contributions and the like, obtained from time to time by the Trust and also the Income from Investments and properties of such Trust Funds.
4. The Objects of the Trust are as under:-
 - a) To establish, maintain, manage, develop, improve and extend and to aid in the establishment, maintenance, managements, development, improvement and extension of Schools, Colleges and other Educational Institutions, libraries and reading room and similar institutions for the dissemination and advancement of education and knowledge.
 - b) To give books and other equipment's including stationery to deserting students and family members of the staff.
 - c) To grant scholarship or otherwise render assistance financial or otherwise to indigent students for the pursuit of education in Schools, Colleges and other institutions of learning and grant awards, citation etc. to respected citizen for devoting themselves for the cause of the society, but in no case, shall the expenditure be incurred outside India.
 - d) To arrange for and to aid, by way of financial assistance or otherwise, individuals or institutions for the publications of books for free distribution and no profit basis for imparting general technical, medical, spiritual and scientific knowledge.
 - e) To organize educational & cultural competitions, debates and examinations and distribute prizes.
 - f) To construct, maintain, manage, improve, extend and aid in establishment maintenance, development and extension of hostel for the benefit of students and staff orphanages for the poor & needy, Homes for the aged and destitute.
 - g) To purchase properties or construct buildings for the purpose of the Trust's use.
 - h) To acquire or otherwise take over institutions having object similar to those of the Trust and which are not run for profit and to maintain, manage, develop, improve and extend the same,

- i) By way of sub serving the above objects, to contribute, donate or otherwise provide funds for institution, enjoying Exemption under section 80-G of the Income-tax Act, 1961.
- j) To organize voluntary groups for achieving the objects of the Trust.k). To borrow any monies from any person, firm, company, bank, Government or other body, if needed for any purpose of the Trust on such terms as the trustees may deem fit and with or without furnishing security of the assets of the trust as may be necessary for the benefit of the trust and for more effectively carrying out the objects of the trust provided however the trustees unanimously agree on such borrowing and limited to the terms of their decision or agreement and to authorize two or more of the trustees to execute such documents deeds papers etc, as may be necessary in connection therewith.
- k) To do all acts and deed or things which are lawful, necessary, incidental and conducive to the attainment of the objects of the trust.

The above objects shall be independent of each other and the Trustees may, from time to time set apart and apply funds of the Trust for carrying out any specific object of the Trust as they may deem fit.

5. IT IS FURTHER PROVIDED:

- a) There shall be Board of Trustees for the Trust. The Board shall consist of minimum Two and Maximum Seven Trustees.
- b) The Author of the Trust has declared himself to act Managing Trustee and shall appoint other Trustees. In pursuance of such a power, he hereby appoints the following Trustees. Besides the Founder Trustee, the following Trustee shall be the First Trustee:
1) K.Sunitha Devi w/o E. Sendhil Kumar

The above office Bearers along with Founder Trustee shall hold post unless they voluntarily or otherwise decide shall continue to be trustees during the term of their natural lives.

6. It is hereby declared that this Trust and its objects implementation shall not be for the benefit of any particular caste, creed and religion, etc.
7. It is hereby declared that no activities of the Trust will be carried outside India.

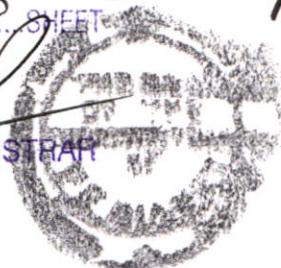
Further Resolved that:

8. "The Trust should carry out activities which are purely charitable in nature not carry on any activity with the intention of earning profit".
9. When there arises a casual vacancy for the office Managing Trustee shall have the power to appoint a person from general public as a trustee and fill the vacancy.

10. The Managing trustee shall be the Chief Executive officer and shall be in charge of day to day affairs of the trust.
11. The Managing trustee shall discharge all statutory obligations and represent the trust in all proceedings including court of law.
12. The Managing trustee shall employ persons necessary or useful for carrying out the objects of the trust on such terms and conditions he may deem fit. To remove any employee of the trust.
13. The Managing trustee shall delegate his powers and authority in respect of administration of the trust to any trustee for a temporary period.
14. The Board shall meet as often as necessary to transact the business relating to the Trust, provided that there shall be meeting of the Board at least once every three months.
15. In the absence of the Managing Trustee, the Trustees may elect any one from themselves to conduct the proceedings.
16. A minute book shall be maintained for recording the resolutions passed at the meeting of the Board and the same shall be signed by all Trustees present.
17. A quorum for a meeting of the Board shall be Two.
18. In all matters pertaining to the Trust, the decisions of the majority of the Trustees shall be final. In case of equality of votes, the Managing Trustee or expedient shall be eligible to casting vote.
19. The Board shall have power to delegate any of its powers to the Managing Trustees to the extent it considers necessary or expedient.
20. The Trustees shall open one or more account with any Nationalised/Scheduled Bank(s) and such accounts shall be operated by the Managing Trustee or any one of the Trustees to be nominated by the Board of Trustees.
21. The Trustees shall frame such rules, byelaws and regulations as they may deem necessary and for the purpose of proper and effective administration of the Trust, its funds and their proper utilisation in accordance with the object/purposes herein before detailed. It will open the Board of Trustees to alter any of the rules, byelaws and regulations, so that the Trust's affairs can be effectively and property administered.
22. If a Trustee is absent for 4 continuous meetings of the Board of Trustees, without obtaining necessary leave of absence he shall cease to be the Trustees of the Trust. The Trust Board shall however have the discretion to reinstate that member of the Board of Trustees.

23. The accounting year for the Trust shall be 31st March every year and the Trustees shall prepare annual reports and accounts for the said accounting year ending March every year and have the same audited by a Chartered Accountant [Expln. To Sec 288 (2)] and the report and the accounts shall be placed before the Trust Board for approval and shall also be forwarded the Commissioner of Income-tax.
24. The Trustees shall be entitled to invest its funds in the forms and modes as specified in Section 11 (5) of the Income-tax Act, 1961 as amended from time to time.
25. The Board shall have the power to realise or otherwise dispose of any or all the investments from time to time. The Board may utilise the proceeds of such realisation or disposals for any of the objects of the Trust and/or for investments as provided in Clause 15 above.
26. All investments shall be made by the Managing Trustee in the name of the Trust. The Trust shall take any decision by passing resolution and getting the consent of the Trustees by passing a resolution by circulation.
27. The Board hereby confirms that the funds of the Trust shall ensure to the public at large and shall not be applied for any religious purposes or given to religious institutions.
28. Alienation of immovable property shall be done only with the prior approval of the Commissioner of Income-tax (Exemptions), Chennai.
29. For the purpose of the Trust, the Board shall have power :-
 - (i). To purchase, acquire, lease, construct, repair, renovate or otherwise take on rent any land, building for occupation any land, building or immovable property for running the office, schools, patasalas or other educational institutions or hostels run by the Trust.
 - (ii) To co-operate with any institutions and associations having objects same as those of the Trust.
 - (iii) To accept gifts, donations, endowments or properties or moneys on such terms and conditions as may be accepted by the Trustees to as incur any liability on the part of the Trustees in furtherance of the objects of the Trust.
 - (iv). The build corpus out of the amounts donated or use donation for any of the objects mentioned hereinabove as the Trustees may deem it fit.
 - (v). To dispose any movable or immovable property by sale or gift or lease property of the Trust.
30. The properties shall vest with the Trustees and shall form the Corpus of the Trust.



31. If at any time and for any reason, the Trust Board unanimously considers that the object of the Trust could not be carried out to their fulfillment it shall with the prior approval of the Board transfer the net assets to any other Public Charitable Trust or Institution or Institutions having similar objects and which are not run for profit as the Board may determine.
32. It is hereby expressly declared that this Trust is a Public Charitable Trust and shall be irrevocable.
33. The Income and Funds of the Trust will be solely utilised towards the objects and no portion of it will be utilised for payment to Trustees or persons defined in Sec 13 (1) (c) of the Income Tax Act 1961, by way of profit, interest, dividends etc.
34. Any amendment to the Trust Deed will be carried out by passing resolution and getting the consent of the Trustees by passing a resolution by circulation and getting an approval from the Commissioner of Income-tax (Exemptions), Chennai.
35. In case of winding up/dissolution, the net funds would be transferred to institutions having similar objects and enjoying exemption under s.11 and 80G if the IT Act, 1961;
36. It is expressly stated that the Trust will not carry out any activities outside India.
37. At present there is no immovable property in the name of NOVA KALVI ARAKATALAI.
